**Update from Deirdre:**

#### **Massey Matters:**

Sam Farquhar spoke about Massey Matters, a ten year project started in 2006 which is supported by Auckland Council. Massey Matters supports the Massey area by, amongst other things, organising events. They have an action plan for Massey and are currently working on school holiday programmes. They have a Face Book page which is updated daily with jobs, events and other information.

Massey Matters To Me is a project that is working in the three streets of greatest need.

There is a Massey Matters newsletter which Deirdre has copies of if wanted. Travel is a major problem for people in the area with people car-pooling to go to Pak'n Save. If this is not an option they are simply walking to the nearest dairy and paying Dairy prices. A lot of people don't have computer skills so find it hard to apply for jobs. Many need to travel to WINZ to use their computers.

#### **Waitakere Taskforce on Family Violence Projects:**

Kelly Maung, Family Violence Project Leader for Auckland Council presented to the meeting a hand out which showed, in a visual form, the Structural Model of how the Waitakere Taskforce on Family Violence works, and Waves relationship to this.

Kelly went through the highlights of the 2011 year which culminated with White Ribbon Day on 25<sup>th</sup> November.

The 2012 Action Plan which sets the direction for activities during 2012 and supports the objectives outlined in The Waitakere Taskforce on Family Violence Strategic Plan 2010-2015 also formed part of the hand out.

**Workshop and Discussion focus:-**

**Creating better pathways to services for children: Deborah Yates**

Deborah Yates, project manager of the newly renamed Waitakere Children and Family Violence project, reported back briefly on her findings to date, with emphasis on the need for the FV sector to come up with ways to improve referral pathways and access to services for children who experience family violence. Three options were workshopped as possible remedies: 1) a centralised reporting process, along the lines of Your Choice in the mental health sector, 2) child advocates working alongside refuge workers or as social workers in schools, 3) points in the current pathways that could be tweaked and/or better resourced. There was a great response from participants.

**General Business/Announcements:**

Elaine Dyer of VFW mentioned that a new initiative for creating a safe, bully free environment for all children and youth is emerging at this time through MSD, with a high emphasis on collaboration. She pointed out that children exposed to family violence are also at risk of stepping into a bullying role and passing on the power and control abuses inflicted on them. VFW is interested in conducting a scoping process to explore creative ways of involving the whole community in supporting such action. Any agencies interested in being involved, please contact VFW .
